Family, Career and Community Leaders of America (FCCLA) recognizes the accomplishments of a current chapter adviser of FCCLA who has gone above and beyond the in their professional development activities and participation throughout the school year.

The mission of FCCLA is to promote personal growth and leadership development through Family and Consumer Sciences education. Focusing on the multiple roles of family member, wage earner, and community leader, members develop skills for life through: character development, creative and critical thinking, interpersonal communication, practical knowledge, and career preparation.

The purpose of FCCLA is

- to provide opportunities for personal development and preparation for adult life
 - to strengthen the function of the family as the basic unit of society
 - to encourage democracy through cooperative action in the home and community
 - to encourage individual and group involvement in helping achieve global cooperation and harmony
 - to promote greater understanding between youth and adults
 - to provide opportunities for making decisions and for assuming responsibilities
 - to prepare for the multiple roles of men and women in today's society
 - to promote Family and Consumer Sciences, careers and related occupations

DEADLINE:

All applications are due to FCCLA National Headquarters postmarked by April 1, 2019. Nominations sent after the April 1, 2019 postmark deadline will not be considered.

Criteria

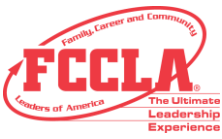
Applicants will be recognized for their accomplishment of Adviser Professional Development hours. Evaluation will be based on the following:

- Additional information will not be considered in the award selection, except for letters of recommendation and the PDU/CEU verification form.
- Active affiliated FCCLA chapter.
- Professional Development Hours included on the application must have been completed and verified between March 1, 2018 and March 1, 2019.
- Educated Adviser Professional Development CEU/PDU verification form.
- Minimum of 5 CEUs or 50 credit hours/units (10 PDU's = 1 CEU) 3 (at minimum) of which must be from FCCLA specific events.
- Three letters of recommendation:
 - School/building administrator
 - FCCLA Member
 - Nominee's FCCLA State Adviser

Official Rules:

- Applicants must be a current Family and Consumer Sciences educator and Family, Career and Community Leaders of America, Inc., adviser.
- Nominations must be typed.
- Winner will be selected based on the judge's evaluation of the given criteria. Judge's decisions are final.
- The nominee receiving the highest score will receive national recognition.
- Adviser Academy CEU/PDUs do not qualify for this award.
- Winner will be selected from eligible nominations.
- For award consideration, nominations must be postmarked by April 1, and sent to FCCLA National Headquarters.
- Winner will be recognized at the 2019 National Leadership Conference in Anaheim, California.

All Educated Adviser Award nominations must be submitted to FCCLA National Headquarters, postmarked April 1.

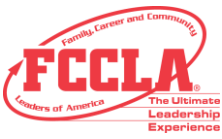
