NATIONAL DISTINGUISHED SERVICE AWARD INFORMATION SHEET

PURPOSE

To recognize outstanding contributions and continuing service to the national organization by individuals whose responsibilities are directly related to Family, Career and Community Leaders of America, Inc., programs.

ELIGIBILITY

Individuals who are local advisers, part of state administration, city supervisors of family and consumer sciences, family and consumer sciences teacher educators, family and consumer sciences education staff of the U.S. Department of Education, who have made outstanding or unique contributions, are eligible to receive the Distinguished Service Award. (Applicants must be current members of the National Alumni & Associates).

CRITERIA

Nominees will be recognized for their service to Family, Career and Community Leaders of America, Inc., in one or more of the areas listed below. Nominees receiving a total of 50 points in one or more areas are eligible to receive the National Distinguished Service Award. There is no restrictions on the number of applicants chosen to receive this award annually.

- A. Projects/programs implemented for the national organization. (50)
- B. Publications authored that relate to the purposes/mission of the organization. (50)
- C. Materials/plans developed to help teachers and prospective teachers make Family, Career and Community Leaders of America, Inc., an integral part of family and consumer sciences on a national level. (50)
- D. Significant research conducted that relates to the national organization. (50)
- E. Leadership positions held in the national organization. (50)
- F. Other significant contributions to the national organization. (50)

Two letters of recommendation must be included.

Official nomination forms are due to NATIONAL FCCLA HEADQUARTERS postmarked by December 15. Nominations sent after the December 15 postmark deadline will not be considered.

D. Significant research conducted that relates to the national organization. (50 points maximum)

E. Leadership positions held in the national organization. (50 points maximum)

F. Other significant contributions to the national organization. (50 points maximum)
