

2023 INDUSTRY IMMERSION ADULT COVID SAFETY AGREEMENT & WAIVER FORM



FCCLA is offering an in-person attendance at 2023 Industry Immersion to affiliated advisers and chaperones pursuant to local government orders permitting such gatherings at this time. FCCLA requires all attendees and National Staff to comply with safety precautions specified in the state, local government, and CDC guidelines.

Any person testing positive for COVID-19, will be refused admittance to the in-person 2023 Industry Immersion. Any person refusing to comply with required safety protocols will be required to leave the meeting at their own expense. Before receiving your name badge and registration materials on-site and entering the conference area, you will be asked to acknowledge and accept the following terms and conditions. A signed form per attendee will be required. I specifically affirm and attest to the following, to the best of my knowledge:

- I confirm that I have not knowingly been exposed to anyone testing positive or presenting symptoms of COVID-19 within the last five (5) days before arriving on site.
- I confirm I have not been diagnosed with COVID-19 and not yet been cleared as non-contagious by my medical provider or public health authorities, consistent with CDC guidance.
- I confirm if I test positive for COVID-19, I will immediately quarantine myself and leave the meeting area and notify National FCCLA Staff.
- I expressly agree to fully comply with appropriate COVID-19 health and safety measures and protocols set for attendance at 2023 Industry Immersion in accordance with applicable state and local requirements, which may include the requirement to show vaccination status or testing results, wear face masks at all times, and maintain appropriate social distance.

Assumption of Risk: The COVID-19 virus continues to spread from person-to-person contact and other means, and people reportedly can spread the disease without showing symptoms. Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death. Therefore, if you choose to participate in the 2023 Industry Immersion, you may be exposing yourself to or increasing your risk of contracting or spreading COVID-19, despite our safety precautions. I hereby choose to accept the risk of contracting COVID-19 for myself or my family.

Waiver of Lawsuit/Liability: I hereby forever release and waive my right to bring suit against FCCLA and its officers, directors, managers, officials, trustees, agents, employees, or other representatives in connection with exposure, infection, and/or spread of COVID-19 related to my participation in the 2023 Industry Immersion. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, based upon claims of negligence.

I certify that I have reviewed FCCLA Safety Agreement above with and agree to follow the protocols as stated throughout the conference. I understand that all attendees not adhering to the safety protocols will not be admitted into the conference area or into any sessions.
