The proposed Standing Rules for the 2024 FCCLA Business Session are as follows:

#### **1. Seating and Deportment**

1.1 Upon arrival, Voting Delegates are required to proceed to the designated Voting Delegate sign-in area, presenting their official name tag and voting delegate ribbon. Prior to being seated, delegates must submit their signed Delegate Agreement and sign in as a Voting Delegate for their state.

1.2 Voting Delegates are expected to remain within their designated section until the conclusion of the Business session. In the event that a Delegate needs to leave before the scheduled break, they must sign out, noting the time of departure, and surrender their Voting Delegate Ribbon along with any voting privileges during their absence. Upon returning to the Delegate reserved section, the Delegate must sign back in, reclaim their Voting Delegate ribbon, and resume their voting privileges for the remainder of the session.

1.3 Audience members must maintain silence and refrain from displaying any signs of reaction, whether in support or opposition to the decisions made by the Voting Delegates. Failure to adhere to this rule will result in the requirement for the audience member(s) to leave the session.

1.4 All participants in the Business Session are expected to maintain decorum and respect. FCCLA reserves the right to request any Voting Delegate or audience member who fails to observe these standards to leave the session and forfeit their voting or attendance privileges.

1.5 The use of mobile communication devices during the session is strictly prohibited. If a Voting Delegate is found using a mobile device during the session, they will be asked to leave the Voting Delegate area and will forfeit their voting privilege for their state.

1.6 Audio or visual recording is strictly prohibited during the Business Session, except for the official production company.

1.7 The doors to the Business Session will be closed at the session's commencement and will remain closed for the duration of the session. Individuals who leave the session will not be permitted to re-enter.

#### 2. Obtaining the Floor

2.1 There are two microphones available on the floor for statements from Voting Delegates regarding motions for discussion or making motions. One microphone is designated for supportive "pro" statements, while the other is for statements of non-support "con" statements. Motions, including inquiries, may be made from either microphone. It is important to note that only Voting Delegates are permitted to approach these microphones.

2.2 A monitor will be stationed at each microphone to oversee Voting Delegate name badges and ribbons and to assist in managing the line.

2.3 Before making a motion or speaking in discussion, Voting Delegates must receive recognition from the presiding officer. Upon being recognized, a Voting Delegate is required to state their name and the state they represent.

#### 3. Motions

3.1 In accordance with the FCCLA Bylaws, Article IX, Section 3.B., only main motions that have been approved by the National Board of Directors and distributed to the states within the disclosure timeline may be voted on by Voting Delegates. Therefore, no motions originating from the floor as new motions or motions to amend previously approved and announced motions are permissible.

3.2 Voting Delegates are prohibited from concluding their points during discussion by moving the previous question.

#### 4. Discussion

4.1 Each motion allows a Voting Delegate two points of discussion, each lasting no longer than one minute. The second point of discussion is permissible only if there are no other delegates who have not yet spoken on the question and wish to address the assembly.

4.2 Discussion will be constrained to five "Pro" statements and five "Con" statements. Pro and Con microphones will be utilized alternatively to ensure balanced participation.

4.3 Discussion on a main motion will conclude, and the motion will be put to a vote within 15 minutes of its initial statement.


#### 5. Other

5.1 The Minutes of the Annual Business Meeting will be ratified by the National Council at the subsequent Executive Council meeting.

5.2 If any of the published motions for National Bylaw Article Amendments are lost, a motion will be assumed for the adoption of each divisible section without further debate. The delegates will be allowed to vote on each paragraph or section individually and those that receive a 2/3 vote will be adopted as amendments to the bylaws.

#### <u>Rationale</u>

**Revised Section 2. Chartered State Associations** – Additional U.S. territories were added and duplicative language was removed.

**Current Section 3. Regions** – Regions are removed as they have a limited role in the organizational structure, and primarily only influence governance. Regions are currently only used to determine representation on the National Officer Candidate Nominating Committee, National Executive Council elections, and State Adviser positions on the National Board of Directors. Policies for the national officer election nominating committee will be developed to guarantee a balanced rotation of representatives. The removal of regional representation emphasizes that the election of National Officers and state adviser board representatives should prioritize qualifications over geographic location. Removing regions does not limit member opportunities, but creates more equitable representation for all.

**Revised Section 3. Affiliated Chapters** – This language was edited to provide clarity for affiliation of chapters and members.

Revised Section 4. Independent Affiliated Chapters – This language was edited to provide clarity for affiliation of chapters and members.

**Revised Section 5.** Active Membership – The language "through grade 12" was removed to incorporate post-secondary students as permissible members of the National Organization. The word "active" was removed as it is not a qualification for membership. The language addressing voting privileges was removed as this is addressed in Revised Article VII Section 2. The language addressing holding office was removed as this is addressed in Revised Article V Section 1.

National Executive Council – The addition of the provision to limit national officer positions to high school members reinforces the core principle of youth leadership within FCCLA. This approach ensures that the National Executive Council remains authentically representative of the organization's primary demographic and is composed of individuals who directly understand the experiences and needs of members. By prioritizing high school members for these roles, FCCLA strengthens its commitment to nurturing youth leaders and maintaining a dedicated youth voice in its governance structure. One-year term until successors are elected will be moved to the Policies and Procedures Manual. Policies and Procedures Manual – Section V. National Executive Council; Pages 40-45.

**Revised Section 1. Responsibilities** – The list of "duties" (from Current Section 5) have been realigned to "responsibilities" that the National Officers are expected to perform as the elected representative body.

**Revised Section 2.** Nominations and Qualifications – Specifications were added to this section to clarify the qualifications of a candidate for National Officer elections.

**Revised Section 3. Relationship with the National Board of Directors** – Current Article VIII was moved to this section to align with the responsibilities of the National Executive Council.

- H. Expenses. The board shall make provision for the reimbursement of expenses incurred by its members in attending meetings and conducting official board business that are not otherwise covered or contributed.

#### Section 5. Committees of the Board

There shall be an executive committee, standing committees, and ad hoc committees of the board. Standing committees shall include: Finance Committee, Program Committee and Communications/Membership Committee. Ad hoc or advisory committees and task forces may be appointed by the chairperson of the board with the approval of the board, and they shall report to the board through the appropriate standing committee.

A. Executive Committee. The members of the Executive

chairperson shall perform all duties pertaining to the office of chairperson. The vice chairperson shallserve as chair elect and succeed to the position of chairperson at the next election of officers. The chairperson shall appoint all standing and ad hoccommittees of the board annually.

- C. Treasurer. The treasurer of the board shall serve as chair of the Finance Committee; shall have authority to sign any official documents duly prepared and requiring signature of the treasurer of the board.
- D. Secretary. The secretary of the board shall record all motions and actions and keep a record of allmeetings. The secretary's records shall be kept in the headquarters office of the organization.

#### Section 4. Meetings of the Board

- A. Regular Meetings. Each year, there shall be at least two Board meetings generally scheduled at least six months in advance, which are referred to as regular meetings. One regular meeting of the Board may be held in conjunction with the national annual conference or at another time as determined by the Executive Committee in consultation with the Board in the best interests of FCCLA. One regular meeting each year shall be at the site of the national headquarters or otherwise as determined by the Executive Committee.
- B. Special Meetings. The Chairperson of the Board or voting directors of the Board may call for a special meeting upon written request of five voting directors. Written Notice of any special meeting shall be sent to each director at least 15 5 business days in advance, with a statement of time, place and meeting agenda.
- C. Alternative Action. Any action required by law to be taken at a meeting, may be taken without a meeting if a consent in writing, setting forth the action so taken, is agreed to by all of those entitled to vote with respect to the subject matter thereof.
- D. Use of Telecommunications. As determined by the Executive Committee, arrangements may be made for directors or members of a committee to participate in a meeting of the Board or committee by means of a conference telephone or other telecommunications device which allows all persons participating in the meeting to hear each other and such participation in a meeting shall be deemed present in person at such meeting.

#### Section 4. Meetings of the Board

- A. Regular Meetings. Each year, there shall be at least two Board meetings generally scheduled at least six months in advance, which are referred to as regular meetings. One regular meeting of the Board may be held in conjunction with the national annual conference or at another time as determined by the Executive Committee in consultation with the Board in the best interests of FCCLA. One regular meeting each year shall be at the site of the national headquarters or otherwise as determined by the Executive Committee.
- B. Special Meetings. The Chairperson of the Board or voting directors of the Board may call for a special meeting upon written request of five voting directors. Notice of any special meeting shall be sent to each director at least 5 business days in advance.
- C. Alternative Action. Any action required by law to be taken at a meeting, may be taken without a meeting if a consent in writing, setting forth the action so taken, is agreed to by all of those entitled to vote with respect to the subject matter thereof.
- D. Use of Telecommunications. As determined by the Executive Committee, arrangements may be made for directors or members of a committee to participate in a meeting of the Board or committee by means of a conference telephone or other telecommunications device which allows all persons participating in the meeting to hear each other and such participation in a meeting shall be deemed present in person at such meeting.

Committee shall consist of all officers of the board, the chairpersons of all standing committees, the president of the National Executive Council and the executive director. The Executive Committee shall report all its interim actions in writing at the next regular meeting of the board for approval. Meetings of the Executive Committee shall be held at the call of the chairperson. The agenda and information relative to items of business shall be sent in advance whenever possible. Conference telephone meetings shall be permissible.

B. Standing Committees. Following the National Leadership Conference and upon recommendation of the incoming officers of the board of directors and the incoming national president, the chairpersons and members of standing committees shall be appointed by the chairperson of the board. The chairpersons of standing committees shall be directors. Non-board members may serve as voting members of the committees, except the Finance Committee. The vicepresident of finance of the National Executive Council shall serve as a member ex officio of the Finance Committee. There shall be at least one member of the National Executive Council on each standing committee. Each committee shall meet at least two times a year.

#### Section 6. Quorum

A majority of the voting members of the board shall constitute a quorum for the transaction of business. The same shall pertain to all committees of the board. Proxy voting is not allowed.

The Board may by resolution limit the powers of the Executive Committee. There shall also be a Finance Committee whose members shall be appointed by the Board. #### <u>Rationale</u>

**Revised Section 1. Authority and Powers** – This language outlines the structure and responsibilities of the National Board of Directors, ensuring transparency and accountability in governing FCCLA's property, business, and affairs, while emphasizing the Board's role in policy setting and sound management.

**Revised Section 2. Directors** – Directors were listed in a more concise manner to provide clarity as to authority and representation. Language was added to indicate that board positions are available to those listed but if a position is unfilled, the organization still has the flexibility to function with that vacancy. #### <u>Rationale</u>

Language has been included to enable the Board to provide advanced notice of bylaw amendments by expanding the standard 30-day notice period. The existing Section C has been divided into two distinct sections to enhance clarity and protect the National Organization from motions presented on the floor without adequate notice for states to review and deliberate. In response to legal counsel's advice, two brand-new sections, F and G, have been introduced to the bylaws. This change benefits all members by enhancing transparency and ensuring fair consideration of motions.
