This checklist is designed to help your chapter track and complete the various opportunities required to earn the FCCLA Ultimate Chapter Award. Each opportunity listed contributes points toward the award, and this resource provides a clear and organized way to monitor your chapter's progress throughout the year.

As you work through the checklist, be sure to review the detailed descriptions provided for each opportunity. These descriptions offer concise guidance on what your chapter needs to do to fulfill the requirements and earn credit in the FCCLA Portal. Once an opportunity is completed, simply check it off to keep your chapter on track to achieving this prestigious recognition.

Stay engaged, stay organized, and work together as a chapter to meet the milestones necessary for the Ultimate Chapter Award. This checklist is your roadmap to success!

How to Earn the Award

To earn the FCCLA Ultimate Chapter Award, your chapter must complete a specific number of opportunities based on the highest grade level of students within your chapter. The number of opportunities required reflects the level of involvement and leadership expected:

- For chapters with members up to grade eight (8): You must complete at least 55 opportunities.
- For chapters with any members in grade nine (9) and above: You must complete at least 70 opportunities.

Types of Opportunities

To earn the FCCLA Ultimate Chapter Award, your chapter can accumulate credit through three types of opportunities, all tracked within the FCCLA Portal.

- **Automatic Tracking Opportunities:** Credit is awarded automatically when your chapter completes specific actions in the FCCLA Portal, such as affiliating members or registering for events.
- Application-Based Opportunities: Earn credit by submitting applications for awards, grants, or recognition programs directly through the FCCLA Portal.
- Reflection-Based Opportunities: Share your chapter's experiences and achievements through surveys or reflections in the FCCLA Portal to earn credit.

Being affiliated means that both chapter members and advisers are entered in the FCCLA Portal and affiliation fees are paid in full. If your chapter status shows as "Pending," credit will not be awarded. Late submissions cannot be accepted for this opportunity. Credit will automatically appear on the chapter's dashboard if the chapter is fully affiliated by November 1. No further action is required.
	Submit evidence of your FCCLA Chapter creating a Chapter Recruitment Plan	July 31	Reflection	Credit will be earned when your FCCLA Chapter develops a formal recruitment plan for the current affiliation year outlining membership goals, outreach strategies, target audiences, and promotional methods. The plan should include specific action steps for attracting new members and retaining current members. To receive credit, upload your completed recruitment plan through the Reflection survey in the FCCLA Portal (Surveys/Applications > Ultimate Chapter Award).
	Chapter Advisers update member titles in the Portal	July 31	Automatic	Credit will be earned when at least one (1) member title is updated by a chapter adviser in the FCCLA Portal by July 31. Keeping titles current maintains accurate records and reflects the active roles and responsibilities within the chapter. Credit will automatically appear on the chapter's dashboard once at least one (1) member title is updated. No further action is required.
	Chapter advisers verify their email address in the FCCLA Portal	July 31	Automatic	Credit will be earned when at least one (1) chapter adviser verifies their email address in the FCCLA Portal on their landing page. Each adviser must use a unique and valid email address to ensure they receive important FCCLA communications and updates. Credit will automatically appear on the chapter's dashboard once an adviser's email address is verified. No further action required.
	Chapter members verify their email address in the Portal	July 31	Automatic	Credit will be earned when at least one (1) chapter member verifies their email address in the FCCLA Portal (Edit Information Tab). Verifying an email address ensures members receive the weekly Member Minute newsletter and other important FCCLA communications. Although it is only required for one (1) member to complete this step to earn credit, chapters are encouraged to have all members verify their email addresses. Credit will automatically appear on the chapter's dashboard once an email address is verified. No further action is required.



Chapter members add to the FCCLA Resume and/or Service Hours		Automatic	Credit will be earned when at least one (1) chapter member logs achievements or service hours in the FCCLA Portal under the "Resume" or "Service Hours" sections in the My Journey tab. This process helps members document their personal growth, leadership development, and involvement in FCCLA. Although it is only required for one (1) member to complete this step to earn credit, chapters are encouraged to have all members regularly update their resumes and service hours. Credit will automatically appear on the chapter's dashboard once entries are submitted. No further action is required.
Membership increased by at one (1) member compared t previous year		Automatic	Credit will be earned when your FCCLA Chapter shows an increase of at least one (1) member compared to the previous year's total membership as of May 31. Credit will automatically appear on the chapter's dashboard once your chapter affiliates at least one (1) more member than the prior year as of May 31. No further action is required.
Submit evidence of your FCC Chapter hosting a back-to-so night event		Reflection	Credit will be earned when your FCCLA Chapter hosts a back-to-school night event to introduce FCCLA, share the year's plans, and engage families and school stakeholders. Acceptable proof may include photos, agendas, schedules, handouts, or a short event summary. To receive credit, submit evidence of the event by uploading proof through the Reflection survey in the FCCLA Portal (Surveys/Applications > Ultimate Chapter Award).
Submit evidence of your FCC Chapter hosting a fall memb recruitment event		Reflection	Credit will be earned when your FCCLA Chapter organizes and hosts a membership recruitment event between August 1 and December 31 to encourage students to join FCCLA. Acceptable proof may include event details, photos, agendas, flyers, or summaries that highlight how the event supported recruitment efforts. To receive credit, submit evidence of the event by uploading proof through the Reflection survey in the FCCLA Portal (Surveys/Applications > Ultimate Chapter Award).
Submit evidence of your FCC Chapter hosting a spring membership recruitment ev	July 31	Reflection	Credit will be earned when your FCCLA Chapter organizes and hosts a membership recruitment event between January 1 and May 31 to encourage students to join FCCLA. Acceptable proof may include event details, photos, agendas, flyers, or summaries that highlight how the event supported recruitment efforts. To receive credit, submit evidence of the event by uploading proof through the Reflection survey in the FCCLA Portal (Surveys/Applications > Ultimate Chapter Award).
Submit evidence of your FCC Chapter recognizing new or returning members on socia media	July 21	Reflection	Credit will be earned when your FCCLA Chapter highlights new or returning members on its social media platforms to promote engagement and celebrate membership. Acceptable proof may include screenshots or links to the posts. To receive credit, submit evidence of your Chapter's recognition posts by uploading proof through the Reflection survey in the FCCLA Portal (Surveys/Applications > Ultimate Chapter Award).
Submit evidence of your FCC Chapter developing a promo bulletin board		Reflection	Credit will be earned when your FCCLA Chapter designs and displays a bulletin board to promote FCCLA, recruit new members, or showcase the achievements of current members. Chapters may use resources provided in the FCCLA Brand Hub or create their own materials to design the display. To receive credit, submit evidence of the bulletin board by uploading proof (such as photos) through the Reflection survey in the FCCLA Portal (Surveys/Applications > Ultimate Chapter Award).



Apply for FCCLA's Go For the Red Chapter Award	March 2	Application	Credit will be earned when your FCCLA Chapter submits an application for FCCLA's Go For the Red Chapter Award, which recognizes the Chapter's efforts in membership recruitment and retention. Applications must be completed and submitted by the deadline listed on the FCCLA Website and in the FCCLA Portal (Surveys/Applications > National Awards). Credit will automatically appear on the Chapter's dashboard once the application is submitted. If it does not appear immediately, credit will be applied within two weeks of the application closing, as FCCLA will upload the Chapter ID numbers of all submitted applications to ensure proper credit is received.
Apply for FCCLA's Go For the Red Individual Award	March 2	Application	Credit will be earned when an FCCLA Chapter submits an application for FCCLA's Go For the Red Individual Award, which recognizes the outstanding recruitment efforts of individual members. Applications must be completed and submitted by the deadline listed on the FCCLA website and in the FCCLA Portal (Surveys/Applications > National Awards). Credit will automatically appear on the Chapter's dashboard once the application is submitted. If it does not appear immediately, credit will be applied within two weeks of the application closing, as FCCLA will upload the Chapter ID numbers of all submitted applications to ensure proper credit is received.
Apply for FCCLA's Go For the Red Unlimited Award	March 2	Application	Credit will be earned when an FCCLA Chapter under the Unlimited affiliation package submits an application for FCCLA's Go For the Red Unlimited Award, which recognizes chapters that increase their membership numbers from the prior year to the current year. Applications must be completed and submitted by the deadline listed on the FCCLA Website and in the FCCLA Portal (Surveys/Applications > National Awards). Credit will automatically appear on the Chapter's dashboard once the application is submitted. If it does not appear immediately, credit will be applied within two weeks of the application closing, as FCCLA will upload the Chapter ID numbers of all submitted applications to ensure proper credit is received.
Submit evidence of your FCCLA Chapter spotlighting an alumni from your chapter – August	July 31	Reflection	Credit will be earned when your FCCLA Chapter connects with an alumni from your chapter to collect their story of where they are now and spotlights them during the month of August (of the current affiliation year). Alumni spotlights should recognize the individual's accomplishments, career achievements, or continued involvement with FCCLA. To receive credit, chapters must submit evidence of the feature by uploading proof through the Reflection survey in the FCCLA Portal (Surveys/Applications > Ultimate Chapter Award).
Submit evidence of your FCCLA Chapter spotlighting an alumni from your chapter – September	July 31	Reflection	Credit will be earned when your FCCLA Chapter connects with an alumni from your chapter to collect their story of where they are now and spotlights them during the month of September (of the current affiliation year). Alumni spotlights should celebrate the impact of FCCLA on the individual's personal or professional journey. To receive credit, chapters must submit evidence of the feature by uploading proof through the Reflection survey in the FCCLA Portal (Surveys/Applications > Ultimate Chapter Award).



Submit evidence of your FCCLA Chapter spotlighting an alumni from your chapter – October	July 31	Reflection	Credit will be earned when your FCCLA Chapter connects with an alumni from your chapter to collect their story of where they are now and spotlights them during the month of October (of the current affiliation year). Spotlights may be shared through newsletters, social media, or chapter presentations highlighting alumni success stories. To receive credit, chapters must submit evidence of the feature by uploading proof through the Reflection survey in the FCCLA Portal (Surveys/Applications > Ultimate Chapter Award).
Submit evidence of your FCCLA Chapter spotlighting an alumni from your chapter – November	July 31	Reflection	Credit will be earned when your FCCLA Chapter connects with an alumni from your chapter to collect their story of where they are now and spotlights them during the month of November (of the current affiliation year). Chapters are encouraged to feature how FCCLA helped shape their alumni's leadership and career path. To receive credit, chapters must submit evidence of the feature by uploading proof through the Reflection survey in the FCCLA Portal (Surveys/Applications > Ultimate Chapter Award).
Submit evidence of your FCCLA Chapter spotlighting an alumni from your chapter – December	July 31	Reflection	Credit will be earned when your FCCLA Chapter connects with an alumni from your chapter to collect their story of where they are now and spotlights them during the month of December (of the current affiliation year). Alumni features may include written profiles, interviews, or digital highlights recognizing their continued support of FCCLA. To receive credit, chapters must submit evidence of the feature by uploading proof through the Reflection survey in the FCCLA Portal (Surveys/Applications > Ultimate Chapter Award).

Alumni spotlights should demonstrate how FCCLA's mission and programs influenced their education or career path. To receive credit, chapters must submit evidence of the feature by uploading proof through the Reflection survey in the FCCLA Portal (Surveys/Applications > Ultimate Chapter Award).

By submitting the National Program Award Application, your Chapter will automatically earn credit for both the award application and the project summary form (2 total credits). Applications submitted through this award application are considered for national recognition and cash prizes. Credit will automatically appear on the Chapter's dashboard once the application is submitted. If it does not appear immediately, credit will be applied within two weeks of the application closing.
Submit a FACTS National Program Award Application	March 2	Application	Credit will be earned when your FCCLA Chapter develops a project and submits the FACTS (Families Acting for Community Traffic Safety) National Program Award Application through the FCCLA Portal (Program Awards). By submitting the National Program Award Application, your Chapter will automatically earn credit for both the award application and the project summary form. Applications submitted through this award application are considered for national recognition and cash prizes.
